APPROVAL OF MINUTES:

 Councilperson Kenny Richmond moved to approve the minutes as presented for September 8, 2021, meeting, seconded by Councilperson Joseph Wendt. Motion carried, vote of 5 yes. Sarah Burge abstained as she was absent from that meeting.

NEW BUSINESS:
